- I, (referred to hereafter as "**Recipient**", "I" or "**Me**"), in consideration for the Nunatsiavut Government (the "**NG**"), under its Emergency Home Repair Program, providing the me with emergency repairs and renovations as detailed in the Scope of Work attached (the "**Emergency Repairs**") that will be completed by Nunatsiavut Construction (the "**Contractor**") at my residence located at 17 Allen's Road, AGREE TO THE FOLLOWING:
- 1. The Emergency Repairs are offered to me conditional upon the my acceptance of the provisions contained in this document;
- 2. I acknowledge and understand that there are risks involved in the Contractor performing and completing the Emergency Repairs, including, but not limited to, fire, personal injury, loss of life, and damage to property;
- 3. I do voluntarily ACCEPT AND SOLELY ASSUME all risks of damage to property or of injury (including death) that may result or be suffered by me resulting from the performance of the Emergency Repairs by the Contractor;
- 4. I HEREBY WAIVE, RELEASE, DISCHARGE AND AGREE NOT TO SUE the NG and its successors, heirs, executors, and assigns from any and all claims including, but not limited to, causes of action based on personal injury (including death) and damages to personal property, that I may have in the future against the NG and its successors, heirs, executors, assigns, officers, employees, representatives and agents, which may result directly or indirectly from performance and completion of the Emergency Repairs.
- 5. This Release and Waiver of Liability is governed by the laws of Newfoundland and Labrador and Nunatsiavut, as applicable.
- 6. I ACKNOWLEDGE AND WARRANT that:
 - I have read (or have had read to me) each and every one of the provisions of this Waiver and Release of Liability;
 - b. that I understand each of the provisions in this Waiver and Release of Liability;
 - c. That I agree to abide by provisions in this Waiver and Release of Liability.
