Update on Emergency Repair, Critical Repair, and Affordable Home Warmth Repair Programs (2023–2025)

The Nunatsiavut Housing Commission (NHC) is pleased to provide an update on the Emergency Repair, Critical Repair, and Affordable Home Warmth Repair Programs as we prepare for the 2025–2026 building season.

Over the past year, we've made meaningful progress in strengthening our housing services. We are especially proud to announce the successful transition of the Affordable Home Warmth Repair Program to the NHC. This important step would not have been possible without the ongoing support and partnership of the Nunatsiavut Government, and we extend our sincere thanks for their collaboration throughout this process.

We've also welcomed several new team members whose skills and dedication are already helping us improve service delivery and program management. However, we acknowledge that past staffing vacancies have contributed to delays in our timelines. While we are making steady progress, some delays may persist as we continue to build capacity and implement changes.

To ensure repairs are completed efficiently, we are finalizing our Requests for Proposals (RFPs) for upcoming repair projects. These will be issued in the coming weeks, allowing qualified contractors to bid on the work required under each program. Once contracts are in place, we will be able to provide homeowners with more accurate timelines for repair work.

In the meantime, please note that the Critical Repair Program remains open for new applications related to urgent housing needs.

We appreciate the community's continued patience and understanding during this transition period. As always, our team is committed to improving housing outcomes and delivering high-quality services to Nunatsiavut residents.

We will provide further updates as information becomes available. Notices will be posted on our official website and Facebook page, and NHC staff will contact affected residents directly as timelines are confirmed.

Thank you for your support as we continue to grow and improve.
